Natesto is a prescription medicine that contains testosterone and is used to treat adult males who have low or no testosterone due to certain medical conditions.

Raise your T levels while lowering your risk of losing YOUR OWN T PRODUCTION

For men with T deficiency, also known as hypogonadism, T therapy, such as Natesto, is often recommended.

Like other T therapies, Natesto may help raise T levels and provide symptom relief. However, phase 3 and phase 4 studies suggest that Natesto may also lower the risk of losing your own T production.*†

How might this work? Well, Natesto raises T levels each time you take it (3 times per day). Then, between doses, your T levels return to their pre-dose levels. This gives the body a break from T therapy, while still providing symptom relief. It is thought that this break may help limit the impact on a man's reproductive hormones and natural T production.*

*Natesto is used to treat adult males who have low or no testosterone due to certain medical conditions, and is not indicated for any other health condition.

†T production was assessed by measuring T levels and hormones in a phase 3 study of 306 men and a phase 4 study of 60 men. Sperm count was also measured in the phase 4 study.



Understanding Natesto SAFETY INFORMATION

Natesto has a low rate of overall side effects. Plus, it has a low risk of certain side effects that are sometimes linked to T therapy.



LOW TRANSFERENCE RISK*

- Transferring T to loved ones may be a concern for men who use topical T gels
- With Natesto, no-touch intranasal application reduces the risk of T transference to female partners and children

LOW RISK OF INCREASING RED BLOOD CELLS*†

NO WARNING FOR BLOOD PRESSURE INCREASES*

- Some T therapies have a warning for increases in blood pressure

Natesto raised T levels to **NORMAL RANGE**

In a phase 3, 90-day study of 306 men with T deficiency, the main goal was to evaluate T levels.

90% OF MEN

Improvements in **SEXUAL FUNCTION AND MOOD SYMPTOMS**

A secondary goal of the phase 3 study was to examine how Natesto affects T deficiency symptoms.

As early as 30 days after starting treatment with Natesto, the study showed some improvements in*:

- **Erectile function**
- **Sexual desire**
- **Intercourse satisfaction**
- **Overall satisfaction**
- **Orgasmic function**
- **Positive and negative feelings**



Innovative, drip-free NASAL APPLICATION

Natesto is a no-drip gel. Each application takes about 10 seconds, applying a thin layer of T that absorbs into the lining of your nose.



—
One pump (5.5 mg) in each nostril 3 times daily, for a total daily dose of 33 mg



—
Each dose should be taken 6 to 8 hours apart: once in the morning, once in the afternoon, once in the evening



—
Try to use Natesto at the same times each day

Before using Natesto, tell your doctor about all of your medical conditions, including if you (cont):

- Have breast cancer
- Have or might have prostate cancer
- Have urinary problems due to an enlarged prostate
- Have heart problems

Tell your doctor about all the medicines you take, including prescription and over-the-counter medicines, vitamins, or herbal supplements.

LEARN HOW to use Natesto

Most men are confident applying Natesto within 2 days. To start, prime the pump, then follow 4 simple steps.



PRIME

When starting a new dispenser, be sure to prime the pump before the first use:

- Hold the dispenser upside down and push down 10 times over the sink, then dry the tip
- Safely wash away any dispensed gel. If any gel gets on your hands, wash them with warm water and soap

No priming is needed for subsequent uses of that pump.

TIP: It's time for a new dispenser when the top of the piston inside reaches the arrow at the top of the inside label. Reveal the inside label by unwrapping the outer flap from around the container.

Once your dispenser is primed, follow these steps for each dose of Natesto.



1. PREPARE

- Blow your nose
- Remove the dispenser cap



2. POSITION

- While looking in the mirror, place your right index finger on the pump and slowly slide the tip inside your left nostril
- Gently tilt the dispenser so that the hole in the tip touches the soft side of your nostril. This helps ensure Natesto is applied in the correct place

TIP: Your index finger should be touching both the pump and the base of your nose.

IMPORTANT SAFETY INFORMATION (cont)

How should I use Natesto?

- Use Natesto exactly as your doctor tells you to. Your doctor will tell you how much Natesto to use and when to use it
- Natesto is for use in your nose (intranasally) only
- Natesto can be used 30 minutes after using a type of nasal spray called sympathomimetic decongestants such as oxymetazoline. Natesto should not be used with other nasal sprays. It is not known if Natesto is safe and effective when used with other nasal sprays



3. PUMP

- Slowly push down on the pump until it stops. When removing, keep the tip touching the soft side of your nostril. This helps ensure the full dose is applied
- Repeat in your right nostril using your left index finger

TIP: Be sure to completely depress the pump 1 time in each nostril to receive your total dose each morning, afternoon, and evening. Natesto should not be administered in other parts of the body.



4. PRESS

- Wipe the dispenser tip with a clean, dry tissue and replace the cap
- Press your nostrils together just below the bridge of your nose and lightly massage for a few seconds

TIP: Do not blow your nose or sniff for 1 hour after using Natesto.

INDICATION

What is Natesto Nasal Gel?

Natesto is a prescription medicine that contains testosterone and is used to treat adult males who have low or no testosterone due to certain medical conditions. Your doctor will test the testosterone level in your blood before you start and while you are using Natesto.

Natesto should not be used by men with breast cancer, or known or suspected prostate cancer.

It is not known if Natesto is safe or effective to treat men who have low testosterone due to aging.

Safety and effectiveness of Natesto have not been established in children younger than 18 years old, and Natesto should not be used by children. Natesto use by children may affect bone growth.

Natesto is a controlled substance (CIII) because it contains testosterone that can be a target for people who abuse prescription medicines. Keep your Natesto in a safe place to protect it. Never give your Natesto to anyone else, even if they have the same symptoms you have. Selling or giving away this medicine may harm others and is against the law.

Natesto is not meant for use in women.

What should I tell my doctor before using Natesto?

Before using Natesto, tell your doctor about all of your medical conditions, including if you:

- Have or have had nose (nasal) or sinus problems or nasal or sinus surgery
- Have had a broken nose (fracture) within the past 6 months
- Have or have had a fracture of your nose that caused the inside of your nose to be crooked (deviated anterior nasal septum)
- Have or have had problems with swelling of the lining of your nose (mucosal inflammatory disorder)
- Have breast cancer

- Have or might have prostate cancer
 - Have urinary problems due to an enlarged prostate
 - Have heart problems
 - Have liver or kidney problems
 - Have problems breathing while you sleep (sleep apnea)
- Tell your doctor about all the medicines you take, including prescription and over-the-counter medicines, vitamins, or herbal supplements.

Using Natesto with certain other medicines can affect each other. Especially tell your doctor if you take:

- Insulin
- Medicines that decrease blood clotting
- Corticosteroids

How should I use Natesto?

- Use Natesto exactly as your doctor tells you to. Your doctor will tell you how much Natesto to use and when to use it
- Natesto is for use in your nose (intranasally) only
- Natesto can be used 30 minutes after using a type of nasal spray called sympathomimetic decongestants such as oxymetazoline. Natesto should not be used with other nasal sprays. It is not known if Natesto is safe and effective when used with other nasal sprays

What are the possible side effects of Natesto?

Natesto may cause serious side effects, including:

- **Nose (nasal) problems.** Signs and symptoms of nasal problems may include runny nose, congestion, sneezing, nosebleed, nasal discomfort, nasal scabbing, or nasal dryness
- **If you already have enlargement of your prostate gland, your signs and symptoms can get worse while using Natesto.** This can include: increased urination at night, trouble starting your urine stream, having to pass urine many times during the day, having an urge that you have to go to the bathroom right away, having a urine accident, and being unable to pass urine or weak urine flow
- **Possible increased risk of prostate cancer.** Your doctor should check you for prostate cancer or any other prostate problems before you start and while you use Natesto

- **Possible increased risk of liver problems.** Signs and symptoms of liver problems may include: nausea or vomiting, yellowing of your skin or whites of your eyes, dark urine, or pain on the right side of your stomach area (abdominal pain)
- **Swelling of your ankles, feet, or body, with or without heart failure.** This may cause serious problems for people who have heart, kidney, or liver disease
- **Enlarged or painful breasts**
- **Problems breathing while you sleep (sleep apnea)**

Call your doctor right away if you have any of the serious side effects listed above.

The most common side effects of Natesto include:

- Increased prostate-specific antigen (a test used to screen for prostate cancer)
- Headache
- Runny nose
- Nosebleeds
- Nose pain
- Sore throat
- Cough
- Upper respiratory infection
- Sinus infection
- Nasal scabs

Other side effects include more erections than normal for you or erections that last for a long time.

These are not all the possible side effects of Natesto. Call your doctor for medical advice about side effects.

Store Natesto between 68°F to 77°F (20°C to 25°C).

Keep Natesto and all medicines out of the reach of children.

Natesto Savings Program Terms and Conditions

The Natesto Savings Program is valid ONLY for patients with private (commercial) insurance. Patients who are enrolled in any federal healthcare program, including, without limitation, Medicare Part D, Medicare Advantage, Fee-for-Service Medicaid, Managed Medicaid, Veterans Affairs, Champus, TRICARE, and Indian Health Service, are not eligible to participate in the Natesto Savings Program. Eligible, commercially insured patients may pay as little as \$0 co-pay on each valid Natesto prescription or refill, up to an annual maximum of \$3500. Once a patient exceeds the \$3500 annual benefit in the plan or payer's benefit year, the patient is responsible for all remaining co-pay or cost-sharing obligations throughout the conclusion of the current benefit year. On each valid Natesto prescription or refill, the Natesto Savings Card benefit may be applied to dispensed quantities of no less than 20 days (2 dispensers) to no more than 90 days (9 dispensers) per prescription dispensed. **The Natesto Savings Program is not health insurance.**

Some restrictions may apply due to state regulations. Patients are responsible for reporting receipt of this coupon benefit to any insurer, health plan, or other third party who pays for or reimburses any part of the prescription filled using the coupon, as may be required by payer or plan rules, or in accordance with any state or federal law. Pharmacists, patients, and prescribers agree not to seek reimbursement for all or any part of the benefit received by the patient through this offer from any third-party payer or from any health savings, flexible spending, or other healthcare reimbursement account.

Cash patients and insured, not covered patients may fill each valid Natesto prescription or refill at the cash price of \$140 for quantities of no less than 20 days (2 dispensers), and not to exceed 30 days (3 dispensers), per prescription dispensed for up to 12 refills. The Natesto Cash Option Program does not process insurance claims. Additionally, commercially insured patients who exceed the \$3500 out-of-pocket maximum for the Natesto Savings Card benefit program and have a co-pay or co-insurance requirement that exceeds \$140 per 30-day prescription in a given 12-month benefit year, according to payer or plan design, may opt into the Natesto Cash Option Program until the new benefit year begins. Patients may not apply the Natesto Cash Option Program payments to any deductible, co-pay, or to any other out-of-pocket spending calculations for any insurer or third-party payer, including any government healthcare program, such as Medicare Part D true out-of-pocket (TrOOP) costs. **The Natesto Cash Option Program is not health insurance.**
